Photographs:

The Trust operates the following policy on its website regarding the use of photographs, to ensure the privacy and safety of learners at the Trust:

- 1. Where learners are named, only their first names are given;
- 2. Where a learner is named, no photograph of that learner is displayed;
- 3. Where a photograph is used which shows a learner, no name is displayed.

By observing these points, the Trust ensures that visitors to the website cannot link images of learners to the names of learners. When choosing photographs for the website, the Trust is mindful of the way learners may appear in them, and will not include images which are in any way inappropriate, such as close-up portrait shots of individual learners, Inappropriate behaviour or learners wearing inappropriate clothing items.

The Trust follows a policy of seeking parents' permission before using images that show learners on the website.

No other private information about learners is ever published on the website such as surnames or contact details.

Website Privacy Policy:

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

What information do we collect?

Our website uses online forms that allow you to contact us or request paper copies of the documentation we have available on our website.

We will only collect personal data that you have consented to; the data collected is managed under our obligations as a Data Controller.

How we use cookies

A cookie is a small file that asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website to tailor it to visitor needs. We use this information for statistical analysis purposes and then the data is removed from the system.
