Photographs:

The Trust operates the following policy on its website regarding the use of photographs, to ensure the privacy and safety of learners at the Trust:

1. Where learners are named, only their first names are given;
2. Where a learner is named, no photograph of that learner is displayed;
3. Where a photograph is used which shows a learner, no name is displayed.

By observing these points, the Trust ensures that visitors to the website cannot link images of learners to the names of learners. When choosing photographs for the website, the Trust is mindful of the way learners may appear in them, and will not include images which are in any way inappropriate, such as close-up portrait shots of individual learners, inappropriate behaviour or learners wearing inappropriate clothing items.

The Trust follows a policy of seeking parents' permission before using images that show learners on the website.

No other private information about learners is ever published on the website such as surnames or contact details.

Website Privacy Policy:

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

What information do we collect?

Our website uses online forms that allow you to contact us or request paper copies of the documentation we have available on our website.

We will only collect personal data that you have consented to; the data collected is managed under our obligations as a Data Controller.

The data we collect may include; email addresses, full names, phone numbers and anything else you pass to us we feel relevant and or you wish for us to keep.

Controlling your personal information

You can choose to restrict the collection of your personal data in the following ways:

- When you fill in our contact forms, you can choose whether we collect your data by clicking yes on the marketing preferences under the contact form.
- If you have previously subscribed to us and changed your mind, then you can get in touch with us either through email or over the phone to change these preferences.

When do we share your information?

We will not sell, distribute or lease your personal data to third parties unless we have your permission or are required by law to do so. We may use your personal data to send you information on third parties if you consent to this.

If you think the information we hold for you is incorrect or incomplete, please let us know as soon as possible and we will correct it promptly.

We are dedicated to keeping your personal information safe. We have put in place appropriate physical, technological, and administrative systems to safeguard and secure the information we collect online to prevent unauthorised access or disclosure.

How we use cookies

A cookie is a small file that asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website to tailor it to visitor needs. We use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser settings to decline cookies if you prefer. This may prevent you from taking full advantage of the website. We take your privacy very seriously and comply with the recent UK and EU laws on handling cookies.
